He read from page 3 that was attached to the resolution handed out tonight which said; The majority of the extra cost is in the error of the Engineer Firm's calculation of the epoxy coated reinforce steel needed in the concrete guardrails. Commissioner McPhail wanted to know why the Engineering firm wasn't responsible for the error. Dan Evans said the Engineer made a typographical error that was discussed in the pre-construction meeting. Mr. Evans said that the error was missed by his office, TDOT and the engineer and the contractor. Mr. Evans said TDOT is the governing authority over the bridge system of the State of Tennessee whether it is city, state county they call all the shots. Commissioner King wanted to know if there was any documentation of that. Mr. Evans said he thinks there is. Commissioner King made reference to the last page 2nd paragraph which said; the undersigned bidder has determined the quality and quantity of materials required; has investigated the location and determined the sources of supply of the materials required; and said he was just curious about that paragraph. Commissioner King also wanted to know if the paragraph he was referring to was a TDOT document. Mr. Evans said it was. Commissioner King wanted to know if the bidder verified the quantities. Mr. Evans said that all quantities were verified by the contactor the Highway Department and the engineer. Mr. Evans said he had a stack of folders that has any work that has ever happened to bridge #2. Mr. Evans said that TDOT has the final say. Commissioner King said his statement comes from that 2nd paragraph and at that point if there was a discrepancy it should have been brought up then. Mr. Evans said he felt like this would have not changed the bids. Commissioner King said he felt like this would have made a difference in the bids. Commissioner McPhail said that if this error was found in the pre-bid shouldn't it have reflected in the final bid. Mr. Evans said that the bids were based on estimated values and that can change especially if you have a project doing a refurbish on a bridge. There was a lot more discussion on this resolution that will be in the county clerk's office on audio to listen to if needed.
