## • <u>Budget</u>

Mr. Gentry said this is the 21 or 22 years without a property tax increase. He also thanked the commission for raises for the employees. He said it's been since 1988 or 1989 since they were able to give a raise of this size which doesn't really make up any ground because of inflation.

Mr. Gentry said the reserves are very healthy almost 30% of expenditures of the budget right now. He said you could almost run the county for 4 months with what reserves are there. He also said last year we were the 2<sup>nd</sup> lowest property tax county in the state. He said that this year we are 4<sup>th</sup> because some of the counties have gone through some reappraisals and their rate dropped below ours. He said Sevier County and Loudon County dropped below us. He said we are going through a reappraisal cycle right now and will use the new reappraisal numbers next year which will probably make us the lowest.

#### Airport

Mr. Gentry said the airport runway lights took a direct hit from lighting. He said when it gets dark the airport is not operable. He also said a company from Kentucky is coming to look at them.

# • Properties Committee

Properties Committee will meet with School Board Committee on August 2<sup>nd</sup> at 5:30pm at the Higher Education building. He said they will meet about 20 minutes early to go over the bids that came in from the 911 center fire marshal. He also said the bids came in extremely high and wants to talk about other options at that meeting.

### • Waste Connections

Mr. Gentry said the Landfill situations are considerably better. They are still working on a monitoring system.
