- 2. Allow private property owners to exercise their rights to regulate or manage any hog problems on their property in the way they deem necessary and allow such owners to determine whether dogs would be appropriate on their property to curtail crop damage.

Section IV. Property Tax Incentive Criteria Subsection A Category (4) Extraordinary Existing Industry Expansions

For extraordinary existing industry expansions of at risk manufacturers located in McMinn County and outside of any city limits with capital investments in excess of \$50,000,000 and with wages above the local, state and national averages, personal and real property tax exemption and term will be considered on a case-by-case basis. "At risk" will be determined by evaluating whether the company has experienced declining employment trends, declining tax revenues, and the amount of capital investment that has been injected into the local facility within the previous five years. Industry trends will also be considered when evaluating a company as at risk.
