WHEREAS, the Hiwassee Utilities Commission was created in 1972 to serve as a regional wholesale water supplier to Bradley County and McMinn County; and

WHEREAS, the Hiwassee Utilities Commission water treatment plant is jointly owned by Bradley County and McMinn County and serves as a wholesale water supply to both Counties, including the cities of Cleveland, Charleston, Calhoun, Riceville, and Athens; and

WHEREAS, the compact between Bradley County and McMinn County creating the Hiwassee Utilities Commission provides that title to real estate will be placed in the name of the county where the real estate is located and held in trust for the Hiwassee Utilities Commission; and

WHEREAS, the Hiwassee Utilities Commission has determined the need to purchase additional property adjacent to the current facilities and has voted to proceed with the process of negotiation and purchase of 3939 Chatata Valley Road NE, Charleston, TN 37310; and

WHEREAS, the Hiwassee Utilities Commission will meet all the financial obligations related to the proposed purchase of the subject property.
