WHEREAS, in October of 2020 the McMinn County Commission approved a contract with Emergency Reporting; however, that company has since been sold and no longer provides that service counties; and

WHEREAS, the Emergency Services Committee recommends approving a contract with First Due to provide reporting services to all volunteer and municipal departments for a total annual cost of \$42,441 after the first year at \$46,441; and

WHEREAS, the City of Athens will annually reimburse McMinn County \$6,033 annually (\$6,317 year one) and the City of Etowah will reimburse McMinn County \$2,648 annually (\$2,934 year one) for the reporting services; and

Tennessee Consolidated Retirement System

Resolution No. 24-066

A RESOLUTION to increase the minimum monthly service retirement allowance for former, current and future members of boards, commissions, committees, councils and the like with creditable service in the Tennessee Consolidated Retirement System pursuant to Tennessee Code Annotated, Section 835-226.

WHEREAS, Tennessee Code Annotated, Section 8-36-209(a)(2) provides that the chief legislative body of any city, special school district or county may increase the minimum service retirement allowance payable to its former, current and future members of boards, commissions, committees, councils and the like with respect to creditable service established by such '*members pursuant to Tennessee Code Annotated, Section 8-35-226. Said minimum service retirement allowance may be increased as follows:

- Eighteen dollars and fifty-five cents (\$ 18.55) per month effective as of July 1, 2024 for each year of such creditable service, but adjusted on each July I thereafter pursuant to the cost-of-living provisions in Tennessee Code Annotated, Section 8-36-701 (b)(l) and (2); or
- (ii) Twenty-Six dollars and fifty cents (\$26.50) per month effective as of July 1, 2024 for each year of such creditable service, but adjusted on each July I thereafter pursuant to the cost-of-living provisions in Tennessee Code Annotated, Section 8-36-70 1(b)(l) and (2); and

WHEREAS, to set the minimum service retirement allowance under either item (i) or item (ii) above, the chief legislative body of the respective city, special school district or county must pass a resolution authorizing the provisions of either item (i) or item (ii) above and paying the estimated increased pension liability (x) in a lump sum or (y) through an increase in the employer contribution rate of the city, special school district or county for the next fiscal year (July I — June 30) following the adoption of the resolution or (z) through amortizing the amount over a period of time not to exceed ten (10) years from the date of the adoption of the resolution.

WHEREAS, any such resolution must apply to current and future retirees and must become effective on the first day of any quarter following the filing of the resolution with the Tennessee Consolidated Retirement System; provided that if the amount is to be paid in a lump sum or through an increase in the employer contribution rate for the next July I June 30 as provided above, the first

Chairman Curtis said Budget Committee met prior to this meeting and went over some overtime for the Sheriff and approved 2 resolutions for Riceville to send to the full commission.

Commissioner Simpson said the Emergency Services Committee met tonight and brought the resolution approving the Reporting System for Fire Departments to the commission for approval.

13. COMMENTS FROM THE COUNTY MAYOR

Health Department Property—Mayor Gentry said they have been going back and forth mainly being the road that was agreed for the state to build which would have access on Elizabeth Street. He said they wanted the road to be built prior to approving the lot. He said you cannot get money to build a road when you do not have a lot. They finally agreed to call that a constructed right of way. Mr. Gentry said the plat came in on Friday and will circulate around for signatures through the Athens Planning Commission. He said hopefully by the end of the week that will be completed as far as the lot being created and then schedule a closing. Mr. Gentry said they have been in contact with the owners the whole time and they have been very good while the state has been laying out concepts. The State Department has brought in a new project manager and the first one he saw he did not like, so were starting over. He said they do not have much time to finish getting things together so we

need to get our Properties Committee together and start reviewing plans and concepts. He said the properties committee will be spending a lot of time on this project going forward.

Public Safety Committee—Public Safety Committee had met and said 60 days for the Race Track meeting to reconvene which will put the meeting on October 11, 2024. He said they could combine the budget meeting with the sheriff with the Race Track which is October 17th at the jail.

ARC Grant—The state has recommended a Master Plan for the County Forrest. When it got to DC for recommendation it got tied up in all their what DC does but last week, they sent us a contract. So, we will be going forward with a master plan for the county forest to make the most of that property. Mr. Gentry said they signed the contract Friday and they did fund it with \$300,000. Mr. Gentry said this has been on the county's list for decades and it is exciting to finally get to be able to do something with the land.

Bicentennial Park—Phase I Environmental has been complete. He said that was not a requirement in previous types of these grants but this year Phase 1 Environmental was required. Mr. Gentry said it took a while because you must do a survey based on what the neighboring properties are and our neighboring property is a landfill. He said there were a lot of documents that had to be produced because they want to know every storage tank, diesel tank on the property. Mr. Gentry said this has now been filed with ECD and hopefully they will read that and get it back to us so we can start doing final designs on Bicentennial Park.

Mayor Gentry said there is a state law that Mark can get more information on. It is called The Debbie and Marie Domestic Violence Protection Act require suspects in aggravated domestic violence cases to wear a GPS monitoring system if they are released on bond. The law says they must contract with the county which the state pays for it. He said this law was supposed to went into effect in July but there is not a lot of direction on how we do that. Mr. Gentry said meeting with Judge Richardson he is requiring it. He said hopefully next month they will have a county policy done and you meet the guidelines of this policy we will approve everyone. If you meet those requirements, you will be posted at the jail in booking. Mr. Gentry said he wanted the commissioners to know about this requirement when they see a resolution come through next month. McMinn County Sheriff, Joe Guy said by law they must notify the victims anytime that inmate gets out of jail.

Mayor Gentry said he had spoken with Commissioner Crisp about concerns with some of the contracts for the Solar Farms that have been circulating with some of our larger land owners. He said he has been in contact with TVA and they said they do not have any contracts with them in McMinn County. Mr. Gentry said he talked to Commissioner McPhail (Ag Committee) to see if this is something that can be monitored through the Ag Committee. Commissioner McPhail said there is a case in West Tennessee has already been to court on these contracts. Mr. Gentry said he has not seen these contracts but some folks are concerned with what would happen if a tornado with 100 mile and hour straight line wind hit the farm with solar panels and debris goes on someone else land who cleans it up. It could be billions of pieces of chard glass everywhere. Mr. Gentry said the county may need to get some education that could help folks with these contracts to make sure that liability is put on the owner showing that they are liable to clean it up.

Mayor Gentry told the commissioners if they have not received their invitation for the EDA annual meeting it will be on September 30th 2024. Meeting will be at Faith Barn at 5:30. He wanted them to respond if they will be attending.
