Commissioner Millsaps—Recreation Committee met last month and looking at redoing the Bicentennial Park and will be having a meeting tomorrow night with the engineers and invited anyone that wants to come to the meeting.

Commissioner McPhail—Budget Committee met and approved a funding supplement for the perspective Election Commission Administrator for 2 months.

12. COMMENTS FROM THE COUNTY MAYOR

Mayor Gentry said the Airport T-Hanger bid opening was Thursday and did come in overbid. He said they did do alternat bids of 6, 8 and 10 of the six units is right around what is funded if they do not do the apron with it. He said there is a long lead time for the money that funds that so before they call an Airport Committee meeting, he wants to have a full recommendation for some other funding resources to get more hanger space.

Mayor Gentry the pre-bid meeting was held Wednesday March 12th that bid opening will be this Thursday March 20th at 1:00. He said they probably had 4 or 5 general contractors and several sub-contractors were there. After talking to the state, they have been bidding these out over the last couple of months and they have been coming in under budget.

Mayor Gentry said that Commissioner Millsaps mentioned doing a joint meeting with the County Forrest Committee with any of the county commissioners especially those on the Recreation Committee tomorrow at 5:00. He said 3 firms will come in and give their pitch on what they can do for us on the County Forrest Property. Mr. Gentry said that Bicentennial pre-bid is this Thursday at 11:00 am and then the full bid will be April 10th at 2:00 pm. Landfill road pre-bid will be this Thursday and formal bid will be April 11th.

Mayor Gentry said Airport Engineering has to be done every 5 years. So they have placed that add in the paper for request for qualifications which will be due March 25th then the Airport Committee will select which Engineering firm they want to use for the next five years which is a requirement of the FAA.

Mayor Gentry said he talked to the Budget Committee at the meeting today about the Calhoun/Charlston Utility Committee about going forward with the project at Exit 36 and putting that to bid. Mr. Gentry said they have right around \$867,000 to go towards that project and will be meeting with developers to see what they may be able to do with that amount and covering operations of maintenance on that line until an end user is there to cover operations.

Mayor Gentry said he thinks the schools plan to present plans on April 1st in a public meeting to talk about plans for the schools.
